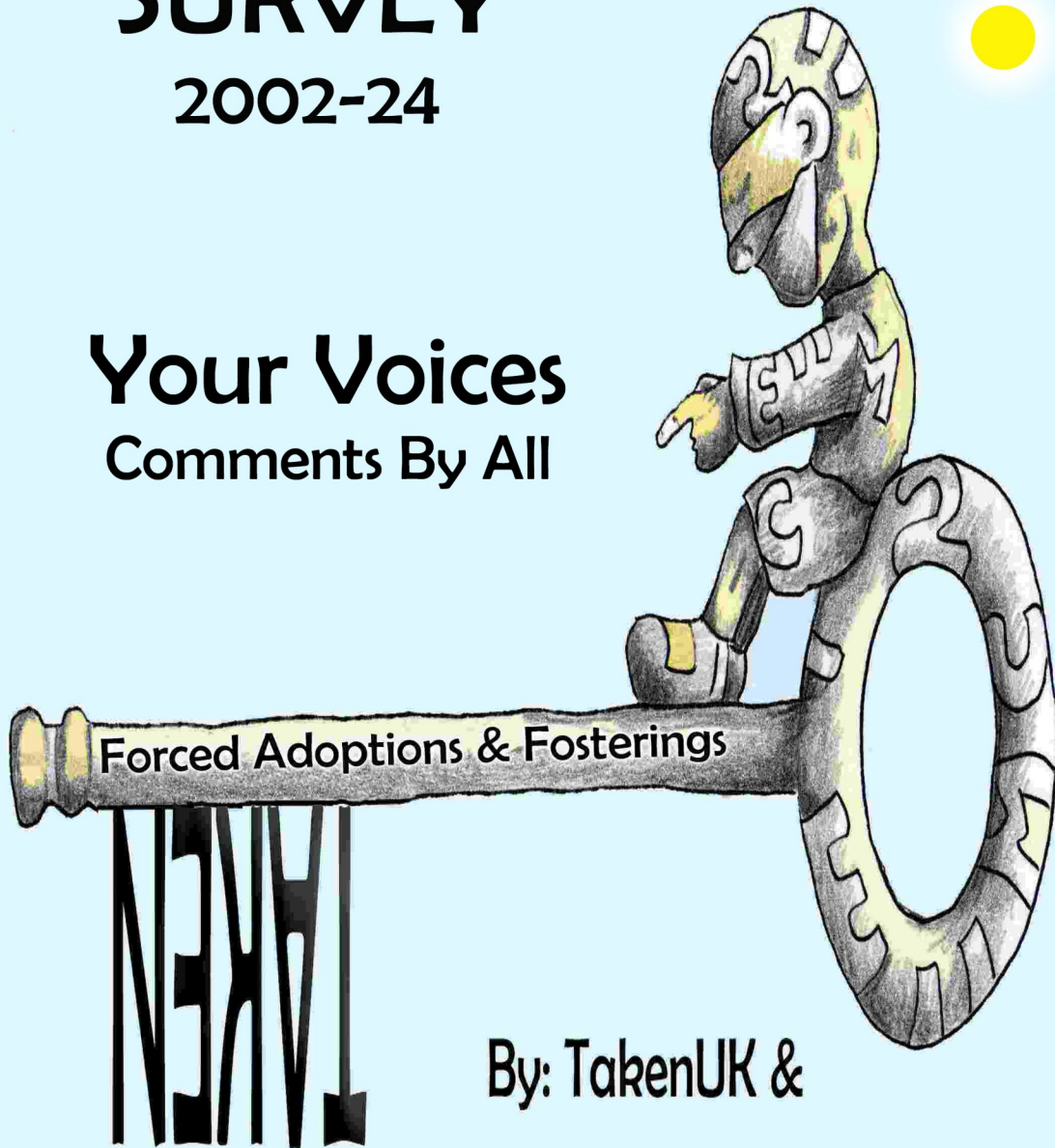

YOUR VOICE SPACE : Do you have any more comments or advice for Government, or us as a community impacted by Forced Adoption and Care proceedings? It's your voice !

1. "Children should be helped to stay with birth families. Adoption is Harmful to all involved when it's forced and cause damage to all. As an adoptee myself and facing possibly losing my daughter to adoption I can say it destroys life's. More money and support needs to be put into keeping families together. And helping parents who may not have had the best upbringing to help them to care for a child."
2. "Body Cameras & unedited third party transcripts to all parties would be beneficial for contextual reports. At the moment there is no oversight & essentially SWs can say anything in their reports & use persuasive language to ensure a grim picture of the parents is painted to get the outcome they desire which isn't always in the child's best interest. False reports fuel animosity & distrust as well which isn't helping an already delicate situation. What is the point of a PD12J or protection orders if they're poorly understood &/or ignored by the agencies supposedly in place to carry those orders out? Both as equally terrifying. Coercive control laws extended to those fostered or adopted so reports can be made historically of coercive control by their "legal" guardians. Remove the profit based system the private psychs & ISWs put in place to bolster flimsy evidence from the council. Make perjury a criminal offence again by using affidavits in cases signed by all parties."
3. "The Somerset rulings and the select committee on CaFA proved all adoptions from 2002 unlawful. All LAs were supposed to review all cases and look for systemic failings, inform birth parents/ adoptees and pay legal expenses. None did. Carcass should be abolished. The blanket approach of one or two letters a year is unlawful. The government should be taken to the echo for trafficking and abduction"
4. "We never understand what is going on as we are dont speak english very well, one of the socail worker called for me a legal solicitor so not even i choosed one , they have been going to the final court hiring with lot of lies and without proof and we had no chance to proof , we didnt understand every single word on the court as we had one interpreter who was also cant interpreting proper. Please im beging for help as they took my children away from me and from a loving family"
5. "I feel they take away kids without trying to support the family and target vulnerable people who leave dv it's left my life a complete mess. I've lived in a nightmare for 2 years for leaving my abuser I don't u destined why they take kids and keep them from loving parents and use ther past trauma to allow this it damages people for life and the social and courts are the abusers in all of this they are above the law it's terrifying the power they have"

6. "Yes LA mantra is to keep familys together yet they insist on ruining familys by ripping them apart with no help for all there damage they cause"
7. "The judge in my grandson's case ORDERED at least once a year I would have physical contact with both grandsons and that the view would be for this to expand to my youngest daughter as time went on. Social services agreed to this then went back to the office and told the adopters to ignore the court order and because their names were not discoverable, it was impossible to bring an action against them and social services refused to honour the agreement made. All this because I'm a grandfather, no criminal history, no substance or alcohol abuser or known for any form of violence in the family."
8. "I wish the early help were given earlier than harm has occurred and truly intended to help, not just to meet a criteria before pursued removal."
9. "I feel every parent is entitled to have a Hearing in a Criminal Court as only children that have suffered abuse should have intervention. The Family Court is based on probability and this is not right and fair."
10. "Children and families SW SS and LA's are a false and misleading title as, as soon as children are removed the 'family' no longer exist and are discarded as not being relevant to proceedings and no support is offered and their is no longer any entitlement and all the focus is then on the adopted family and or foster care family. False reporting and persecution strategies used by CPS are causing intergeneration trauma and disenfranchised grief, are ripping birth families apart and it is paramount to child trafficking by the state for profit in a multi million pound industry which is done in the name of safeguarding and is in most cases not in the best interests of any child/children birth families and where foster care and adoption placements are based on lies in the beginning there will be no good outcomes for anyone. State funding for LA's and CPS services and organisations masquerading as charities, to steal children is criminal in every sense and must be fully investigated and those who are complicit must be held to account and their actions/non action need to be exposed and future practices need to be totally rewritten in the best interests of future generations as yet to be born. The Dept of Education is not fit for purpose and the Secret Family Courts who are corrupt to their very core, must be opened up to scrutiny and not conducted behind closed doors!!"
11. "it is clearly evidenced social services are fabricating information in reports. When will then this cohort of parents that the Chancelor of the Exchequer spoke about in his budget speech March 2024 should not have been subjected to family court be released? When will this scandal be recognised?"
12. "I am now training as a social worker. I hold three degrees no mh no substance misuse clean record I asked for help as child on parent abuse I signed voluntary would not give back my child. Lied about my mh then had to apologise. Discriminated against due to stuff in house apparently that makes you mental ?? Now training as a mh SW. Hold two other degrees in mh and social welfare and nursing"
13. "If social service did what they were there for. There would not be that many children

being adopted. At risk of future harm when you have not even had a parking ticket is wrong.”

14. “Since my children have been removed they have been separated 1 of my children has been sexually assaulted by a carer yet this person still has other cared for children in his care”
15. “I believe that children's identity should remain as it was when they were born even if adopted because by removing their surname is taking away their identity. I also believe that if a parent hasn't been charged with any crime in relation to the removal of children then contact with the parent and children should always be in place”
16. “FJS should not use hearsay evidence. Most of the reports were embellished and biased. The Family court is outdated and shocking.”
17. “Open the damned courts to public scrutiny! Make the family courts bear the same weight of evidence as a criminal court social workers, Cafcass and others cannot lie and get away with it. Enforce perjury laws. Stop using psychologists reports when only 1 session has been had and they've been instructed by court or social services. They have already had their opinions muddled so can't claim to be acting with no direction. The person's own psychologists or therapists should be the ones who make the reports, they know the people they're talking about. Children must be listened to and their rights must be upheld. A child who wishes to stay at home must be allowed and supported to. Hearsay evidence must be stricken from use by social services. The person they claim to quote often is never brought to court for cross examination and the parent isn't even allowed to approach them to say what has been said so they can challenge it. Social services must be forced to use fact not 'opinion', not 'assumption', not conjecture. It must be proven that something has happened or not happened with solid evidence. Parents must be given emotional support for court, especially victims of abuse. It is an overwhelming and terrifying experience. Mental and physical health is often devastated yet rather than trying to lessen that they make it worse and then use it against you. All judges must undergo trauma training, spend a week in a refuge, a week in a care home, a week in social services offices, and any other relevant services to understand what it is to be in these circumstances and how people are affected. Parents panels should be allowed to address judges in the district they work in every month. Judges must know the harm they cause. The same should occur with social services and the police. A monthly meeting where they are forced to sit and listen to what is going wrong, what they can and must do to change it and possibly, what is working well. Social services must provide a community link for parents whose children are in the care system and facilitate a space and support for this. A government body must be created to look at complaints about the specific issue of protection work, family courts and care/ adoption. There must be a service apart from social services that children in the system and their parents can go to for concerns and help. This must be funded by the government but run by an independent body who are not social workers. Physical and mental health of children and parents in the system must be prioritised over the system blindly supporting the people who have stolen the children. The crystal ball technique must

end. There must be no ability to take a child on trumped up claims based on what someone thinks could possibly happen when the child is in a loving home. No parent should lose a child for protection them from harm of the other parent. No child should be dragged away from a loving home. No baby should be removed from the parents at birth or any other time without solid evidence that the child is not being looked after or has suffered harm. No parent should have a child adopted against their wishes unless they are proven to have seriously hurt their child (paedophiles, etc). Parents who need support to parent must be given it and not on a timescale dictated by social services or the family court. It is not acceptable to take a child then tell the parents that the trauma this has caused them is the reason they cannot have that child back. It is simply state sanctioned torture and cruelty. The whole social care system is a joke. The laws must be changed. The services must be held to account. Social workers and judges must not be above the law. Family courts should have juries of peers who must be convinced a child should be taken, not 1 person being misled and directed by incompetence and corruption. The government must stop the services earning money from supposed child protection."

18. "The UK government should not allow adoptive parents to change anything about a child or children that have adopted without permission from the child's or children's birth parents. The UK government should also make sure that adopters keep to the contact rules and should not be allowed to suddenly stop or delay the child's or children's contact with their birth parents. I also think that TV programmes that show families going through the process make sure that they have all of the facts first as there's one soap I ended up not watching anymore as they were showing a child's adoptive relative contacting the child's birth mum to return her child to her as something had happened to the adopters."
19. "UK Adoption is all about the adopters. The idea of a Family Unit no longer exists here because the state demands control and uses children as a mechanism to do it."
20. "Parents who are not abusive and love their children and face challenges caused by various issues including cancer etc should be better supported so they don't end up in a life sentence of pain that forced adoption causes. We need better support given in times of crisis that would prevent the need of removal for non abusive situations"
21. "I think forced adoption in the UK is so inhumane and very extreme. More support could be put in place for families not just going for adoption. Its happening left right and centre all over the UK for reasons that can be supported. Thousands of babies a year being forcibly separated from loving parent/parents. Often mental health, disabilities, domestic abuse, future emotional harm are most common for permanent removal without giving mum and dad support to keep their baby. Social workers twist parents words, lie and mislead and often parents voices aren't listened too or taken into account and fact social workers are just getting away with lying. Family's shouldn't be separated for reasons that can be supported, more than often the child wants their mum and dad and parents want their children. And also more than often social services going for adoption without any actual harm coming to the child! Family courts are saying this "might" happen in the future so we are taking your child. Suicides being caused because

the grief of losing a child is too much pain .. even conditions such as autism and adhd being used to take children away and also parents who have been in care themselves have this used against them when they try start a family. The mistreatment and abusive behaviour towards birth parents from the system is absolutely vile and damn right bullying!!! Human rights are often ignored as well in family courts. Forced adoption needs to STOP. Social workers using it way more often than they should be. It isnt right. Last resort yet it isnt but social workers lie and say its last resort yet no support put in place and removing babies being removed at birth this isnt just a rare thing its happening to thousands all over UK. Removing a baby 2 hours after mum has given birth and often it isnt an emergency at all. This country needs jnvestigated with all these forced adoptions”

22. “Our lives were ripped apart by the family court , social services and other proffesionals. They have caused severe generational life time harm on my children and on us all as a family. They have breeched many of our human rights. Terrible attrocities have been done against us. Fll is a form of modern day witch hunt. It's used against autistic women who are pedantic and speak out. They try to push us to kill ourselves as they can't burn us on the stake anymore. Terrible crimes are being done by the state. All hidden and covered up in secret family court where anything is allowed against us . Psychs are paid many thousands of tax payers money to invent evidence against us . The social worker is allowed to invent anything against us. Family court is a top criminal gang where huge money making is happening taking highly loved children as they are easier in care then the ones who are really being abused. The public have no idea what's going on. The next post office scandal to come out. I nearly killed myself so many times due to being so attacked and tortured as a disabled adult. My children have been severely traumatised. My eldest knows I'm totally innocent and he knows our truth . No one has cares on his voice in any form he has been gas lit beyond.”
23. “The whole process from correct training of social workers to the court system needs rewriting. Mediation should be mandatory until it is resolved to save time and money, and problems can be resolved with all parties, consenting agreements and court as a last result. Early help would be a great introduction and with mediation would stop parties using spurious accusations and delaying the process, if one party dose not consent to mediation then the it should go in the others favour. Social workers should wear camcorders as well as other parties , it would help with their report writing saving time as the recordings can be transcribed and nothing can be misconstrued .”
24. “I believe that all family law practice , local authority powers over mothers and children and Cafcass should be abolished. I see no protection for victims and every harm to innocent people for profit and job creation in the civil service. No mother and child should be separated. If help and support is needed offer it without force and cruelty”
25. “More support is needed instead of removal of children”
26. “I once believed children social care had the intention to help families I have lost all faith in the system and now I am traumatised and cannot trust the system I have had to set up cctv in my own home for my own protection against lies made up about my family”

27. "Assessments are either insufficiently taken or not taken at all even when ordered by a court. childrens services do not seem to have any empathy towards parents ignoring their distress and making biased judgements. Cafcass seem to be following whatever the local authority are reporting without making their own inquiries as a supposedly independent party I find this unprofessional and irresponsible. Local authorities seem to be far more ready to spend funds towards fostering and adoption services than helping parents to keep their children."
28. "Forced adoption needs to be abolished. Real families should be able to sue the local authority for damages."
29. "For the government: If parental rights need to be terminated, why does the child need to permanently need loose their rights? Why is adoption the only legal process where the child's consent of having their life and lineage altered is acceptable but any other circumstances is legally classified as abuse and or human trafficking? Why can't adoption only be available and viable in adulthood at the age of consent and understanding capacity? Why are children with trauma being offered as medical treatment for infertile adults- the only time a child is used as a medical treatment-?, Why is it legally acceptable and procedure for an adoptees medical history to be altered by GPs and why is it not illegal that adoptive parents are allowed to provide their own medical history for the child instead of the childs, thereby putting the adopted child's life at risk? Equally why is it legal for updated medical information not to be passed on either by biological family to the adopters or visa versa?- again, putting peoples lives at risk, why is it legally acceptable for Local Authorities and adopters to threaten police action on biological families if the child seeks the family out? Why is adoption typically only offered under the age of 6?... is it because a small child cannot comprehend or voice what is happening to them, making it easier to not have their consent? Or could it be because adults only want babies, making the adults needs centre instead of the child? The law states that adoption is only to take place when the harm is so severe and no safe persons links to the child is available and or kinship and SGO has failed, so why are 97% of all adoptions forced, most of which no kinship, guardianship or any support was given... in my case, after rejecting and or not contacting safe family and friends to have care, during the final hearing in court, Social Worker repeatedly stated that I was a good mum and when asked about an open or closed adoption the social worker responded and I quote " We would like to request a closed adoption, as we believe their relationship is too good that the placement would potentially break down"- by law, the law was broken, as it is regularly done by family courts.... why is the law repeatedly being allowed to be broken? Why are Social Workers not being prosecuted for lying under oath? Under normal circumstances the sentence carries a minimum of 7 years imprisonment, instead there have been many cases where they have been promoted in their jobs. When safe to do so, why can't care of a child be a coparenting circumstance? Instead, its legal parental/family alienation. Why are parents having their children removed for putting their needs above a child's, yet it is the acceptable basis for external carers to Foster and Adopt for their own needs? When an adoptive parent relinquishes a child back into care, why are they still allowed to have subsequent children in their care (biological or

otherwise)? Why are charities, external carers, social workers etc allowed to do bias research and blame the child for the events they went through? Why are only 3% of 33% of yearly reported abuse by children at the hand of Foster carers being investigated and having intervention? At which point the carers are receiving support not the child and 30% being forced to remain in that placement... that's just the ones reporting. Why are external carers allowed to break their responsibilities such as cancelling contact but if a parent does they are vilified and goes against them? Why are families not being told their rights or support they can access? Why are social workers allowed to use police to FORCE parents into signing VOLUNTARY sections? Why are siblings being forced to be separated and have no contact? That's child abuse at the hands of the local authority no? Kids are being given a job to care for adults and not allowed support or grieve."

30. "Stop the forced adoption and start helping families"
31. "My siblings were forcicably adopted im 16 and now self harm as no support available to deal with the grief im going through. The reason I'm not allowed contact with them is because I am in contact with my mum which I feel is awful because us as children and siblings are completely innocent"
32. "Stop forced adoption it's wrong in every way."
33. "It's a horrible and cruel process for parents and children and I should have been helped not punished and thrown on the rubbish tip."
34. "Forced adoption should not happen More should be done to keep familys together more support not mess familys up this has lasting effects for both the child that is adopted and the parents and other siblings and family members"
35. "I do believe that all social/CAFCASS workers should be wearing body cameras & transcripts used of all meetings used as reports. There is too much emphasis on social workers being "truthful" & birth parents being labelled as bad when context is rarely given, only answers to questions are given not the question & answer. There is also too much emphasis on a future risk of harm but not working with parents to mitigate that risk."
36. "Social workers need to be monitored more closely, make them wear body cams which can be easily accessed by anyone. This would soon change things for the better. At present parents no matter how well prepared have no chance against a social worker and her team, because they have no accountability at all."
37. "Children denied access to birth families also denies rights to children of adoptees to know about the extended birth family and takes away rights for following generations"
38. "What the government and local authority do is gut wrenching and disgusting. There is no help and that is cruel. Can we fight this for a law change? Please."
39. "Reverse adoption orders.... return children to birth families who are yearning for their children.... My children and I have been traumatised, it truly is a living nightmare.... when will this suffering end?"

40. "Bullied belittled degraded humiliated re-traumatised, wrongly criminalised, defamed, my children poisoned against me and placed with identified unsafe men, all my rights revoked even though I still hold PR new pregnancy being used against me even though all circumstances have changed and Considering abortion! I'm going to end up dead my heart and body can't physically take anymore unnecessary pain"
41. "The whole system is not fit for purpose. It's archaic. It should be completely transformed. They are destroying human beings' whole lives. No evidence, just judges deciding on hearsay. None of this is in any child's best interest. Social services ethos is "keeping families together". Clearly one big lie."
42. "I believe they should put more effort into supporting keeping family's together and helping the parents with any courses or therapy rather than forcefully adopting well wanted and loved children and helping adoptive parents with therapy when should be used to support parents"
43. "Our voices are not heard ..bullying tactics in Banff office .if you say anything they cut visits say they don't have staff. No feedback about school or at foster carer never a look at the diary that is supposed to be shown to birth mum NANA...NON relevant ...it's a complete corrupt system and it is not being investigated .complaints buried within local authority that is also the body that runs said children's family centre ...corruption at highest level .Targets ..that's all this is with a power hungry team leader .SARS REQUESTS. 3 YEARS ...STILL WAITING .BREAKING THE LAW!!!!!"
44. "I think it needs to stop and families compensated"
45. "The state of MH treatment via NHS and GPs is pitiful. Even if you get treatment (average 10 years between diagnosis and treatment commencement) they report you to children's services. Similar situation with drug and alcohol misuse, if you admit you have an addiction, your children get removed, which can make addictions worse. No help whatsoever is offered to addicts lest children are removed."
46. "Why aren't social services helping families to reunite nothing in practice is being done"
47. "The Government needs to implement a drastic overhaul in the way that they fund child and adult social care. The year on year statistical increases required to gain local government income streams for "successful" child interventions is creating an avalanche of damaged children and damaged society's. The Key Performance Indicators need to be based on family unification, family support, family integration and they need to be genuinely child focused. My family member only needed minimal help to escape the DV she was being subjected to, but this was refused. She lost her son because she didn't take two nappies to her son's nursery on one occasion and she didn't take a rain coat for him on another occasion because she checked the weather forecast and it said it was going to be sunny all day. Those two events caused her to be referred to The SS, my family has been destroyed by the money orientation that underpins the SS and the LAs income streams, which run to millions every year. My young family member has suffered unspeakable abuse at the hands of his foster carers, he is profoundly disabled, the government owes him a mother, father, grandmother and his health, which we all

know he won't get compensation for. But perhaps if compensation was given to children who have suffered from the LA abuses, then future generations of children will never be subjected to this inhumane treatment, to meet the KPIs set by central government. Until the government changes the way that they demonstrate success, more children will be harmed by the LAs, more children will suffer from abuse, and more children will die from being placed with abusive parents or carers, because the mindset of the LAs is not to protect children but to protect their own careers and to prevent the children's first protectors from getting the support needed to raise their children to become successful adults in the future. Please accept my apologies for my tirade, it's an extremely emotional subject and thank you for doing this research."

48. "More focus on reunification and a way to stop no contact orders for mothers who lost Children through Domestic abuse"
49. "I was astonished to learn that my grandchild was likely to be removed permanently from birth family and adopted and we had to fight to be allowed to care for my grandchild as a kinship carer. Every obstacle was placed in our way. It seemed that non consensual adoption was the preferred route and we had to fight this over a period of one year until we were granted a proper independent assessment which was entirely positive. The contact procedures for grandparents were horrendous and we had to put up with being observed by 2 contact supervisors, with one supervisor after a while who was highly critical of all that we did in contact. However, contact at our house was brilliant and no concerns were raised by the observing senior social worker! In my view, the entire system needs to be revisited and there should be standard procedures involving supporting and understanding the birth family. We had to bear the entire cost of the proceedings which totalled £17, 000!"
50. "There are assessments for psychopathy called the PCL-R (psychopathy Check List) We have a right to assess the architecture for predatory, malicious, inability to show remorse, inability to feel empathy.... I am an engineer with experience designing architecture and by design this is malicious child trafficking on a criminal level architecturally, any expert with a history of credibility will easily identify this criminal architecture. With machines and artificial intelligence, intent or a guilty mind is not required to prosecute for criminal wrong doing, there is more than enough concrete evidence that the roles defined, processes, lack of accountability, etc are architecturally design to criminally child traffick. No policy recommendations have gone through from the recommendations made with from the victims of the Jimmy Savile case. This is a very deliberate child trafficking scheme by powerful very predatory people in systems designed for this corruption. The ofsted inspectors are usually not registered. Some social workers are not registered. A mental health facility holding a child is not registered. Over 300 social workers have been proven to be directors of placement agencies financially benefiting from their decisions to traffick these children. The barrister for a mother against the council was also the barrister for that same council against me. We have proof of all this corruption. This is intentional designed to kill us. My father is dead. My son is stolen. They have my son to someone with a 50,000 mobile home who is dependent on their financial incentives. I went back to the US where I'm

buying a second house I've been prevented from for years as a prisoner in the UK. These homes total over \$650,000. They falsified this fraudulent narrative to steal my son and give him to a poorer family with no benefit to my child only very hefty costs including the life of my father and so much more that's difficult to even begin to describe. They are intentionally killing us."

51. "It's shocking how the team manager, independent review officer, social workers & foster carers, etc continue to breach the judges court order."
52. "Please consider the evidence from extended family and involve them in the court proceedings as they were there. Strangers or people making false accusations and social workers with an agenda are considered more relevant than family and friends and it is not right."
53. "Forced adoptions, severing all contact with birth family should be abolished, even in very severe circumstances. The ripple effects are huge. The secret family court should be opened up. All professionals should wear body worn cameras."
54. "There should be more people from independent companies looking into the stolen children as they think they are above the law and as they are an Island they can do what ever they want without being reprimanded. Legal aid should of NEVER been removed and any legal agreements regards access should be handled by the court not the social workers. As my postal access seems to have stopped even though I have contacted the s.wrks no one can help as the lead social worker and the one handling my case have left with no one taking over. If a case is seen in a different court and illegal loopholes have been used then that court should have the right to question and investigate every single action by them. No one should be made to feel a bad parent or be bullied by a social worker. Especially when there is more than one person who has an issue with how s.wrks are acting or treating people. I had people who stood up for me and my children and they got ignored by the court. I was not supported by anyone and the actions of what happened to me resulted in me trying to take my own life. I was alone my partner was bullied off the island and I was all on my own with no support which made things easier for them. If it wa looked into and found to be illegal what they did to me no amount of money in compensation could ever cover what was done to me and my children. Things like this need to stop."
55. "Family courts to be public as social workers are getting away with manipulating the court and when the concerns are raised by the parents, the judges disregards this information. Social workers have breached human rights, discriminated against and victimised me and my family but when the concerns were raised we were told to keep quiet by our solicitors. The corruption is rife a currently in the family courts. Please refer to all social media platforms to find real families with real stories of their experiences with social workers. Look for stop forced adoption and foster care, Social workers corruption, etc. The list goes on. We need a voice, we need to Reform children's services, and stop this state sanctioned kidnapp, allow us to share our stories on the news channels, news papers etc. We see protests of many things on the news, there has been protests about child abduction in London but not shown on any news platforms."

56. "To triggered to comment"
57. "There needs to be a full investigation into state removal of children as i truly believe money is driving the corruption inside the family courts. I also believe this is a far bigger scandal than the Post office."
58. "The government and social services should focus more on helping families and enabling different types of support to help ensure families can remain together rather than children and families being torn apart and ruined due to either poor judgment, unsupported or unprofessional practices"
59. "I would like to see more help for parents who do struggle mentally not just remove the kids and we have to crack on it's not on"
60. "Adopters shouldn't have the right to cancel indirect contact agreements, these contact agreements should always remain in place and be done properly, not just a couple of lines to say the kid/s are ok. On a note of mention, family members were foster carers for my oldest two children and because they refused to adopt the children, the social services removed my kids to adopters. Regardless of placement/adoption orders, why could the children not have remained safe with my family members."
61. "We need reform throughout children and family services. To listen more to the lived experience. frameworks throughout local and regional adoption agencies differ , some better than others . These should all be the same. Reviews throughout post adoption to be made standard More prevention support"
62. "The family courts need to be free and open to the public to sit in on any hearing without the permission of the judge etc. and that all to be arrested and be imprisoned for any lies or harm or loss they cause for their own gain. Child protection conferences need to be open and audit like the closed private courts stealing peoples offspring. (Child/ren)"
63. "The government should implement the recommendations of the Independent Review of Children's Social Care (eg more Family Help). This would save councils money by reducing the number and massive cost of children in care. It should admit and apologise that many children over many years have been unnecessarily separated from their families (in care or by adoption). It should pay lawyers a reasonable amount of Legal Act to defend families. It should enforce Article 8 - respect for family life - of the Human Rights Act. It should reform the law eg not have a 6 months deadline to decide whether a child should be adopted, possibly only allow adoption if the mother/father truly consents unless it would be impossible for her/him or their family or friends to care for the child and stop putting children in care if they are "LIKELY to suffer significant harm".
64. "The family law courts are not fit for purpose and there should be a public review into corruption in the system. Parents accused of neglect and harm are never able to defend themselves, the judge only hears the lies the Local Authority relays to them without any evidence and those accused given no right to reply from the very start of any complaint made about them. More effort, support and money should be used to keep children with

there families to ensure no emotional harm is caused and swift reunification should be a priority as apposed to keeping families apart as it seems to be now.”

65. “Stop social workers from making false criminal accusations in family court Criminal accusations made in family court should be investigated by police. Social workers knowingly making false allegations should be charged with perverting course justice and striking off . Cafcass should also dealt with in same way. Children should not be removed by LA or Cafcass without proper orders by Family Court. Family Court Judges should have factual evidence before making orders were no finding of facts has been instigated.”
66. “Research & studying Judiciary has revealed so much. Contract Law Tort Registration! Consent check original applications to court, often unsigned Court Orders must be Signed & Court Sealed to be valid Perjury is committed daily No Delay Breached As The prime minister is a barrister, the above is easy to resolve”
67. “Yes all of these workers with children must wear body cams. And they should not conflate evidence or be dishonest. And not ignore parents and Childrens human rights. All legal representatives should also wear cameras and parents given video copies. All childrens report must be shared with birth parents. Sibling contact must happen regularly without fail.”
68. “There needs to be tighter measures on social workers and reviews. They should not be allowed to lie, predict the future, or refuse to look at evidence. If a complaint is made then the social worker should be changed. In meetings a supervisor should be present. They should not be allowed to lie in court documents.”
69. “Yes adoption should be removed altogether we need more help from social services as that is what they are there for not what they have been doing by Stealing our children for the money we don't go to a social workers house and intervain and tell them how to raise they children why should we be any different I hope that we can over turn these nasty horrible social services and family courts it's disgusting how they can rip a family apart even if they THINK the child/children form they only place they feel loved and safe I understand that some parents need more help than others as we are all different but that doesn't mean we have to have the agernizing pain af our families rip apart and left wondering if we will ever see each other again or even see our children again and our child feeling scared and frightening and alone we need to stang together and say enough is enough stop Stealing our child for their money it inhumane”
